- c. Townhome Backflow Inspections

- d. Tree next to 1415 N King James Ln was removed.
 - Too much utility in the way to grind stump but will cut as far below surface as possible and place sod over the top. Then will replace tree in adjacent location.
- e. Mission St Fence Repair Scheduled for 8/27-9/3

6. New Business:

- Newsletter Ideas
 - i. Claudia noted a few items to be placed in next newsletter.
- b. Transferred \$10,653.70 in July from Operating to Reserves per 2021 schedule
 - i. Now need approval to transfer \$755.49 back to operating for the Catch Basin Scoping Project. Ron to send form approving transfer.
 - ii. Will do a similar transfer back when crack sealing complete.
- c. Concerning recent near misses between vehicles, WEB will email to all re traffic rules (stop signs, speed limits, etc.).
- d. 1003 N King James called re CC&R notice of brown lawn saying he was complying with Liberty Lake Sewer & Water recommendation to reduce irrigation. Board decided that until reductions in irrigation are mandated, landscape rules will still apply.
