Winter Traffic Safety:

Please drive carefully through the neighborhood during snowy and icy conditions. Snow plowing will occur once the snow accumulation reaches 2-3 inches. De-icing liquid will be utilized at the main gate entrance and street hills when freezing conditions are predicted. Residents who have rubber curb ramps at their driveways are asked to mark each end of their ramp with reflective safety cones or posts. HOA Operations Participation Survey
